## 2022 (Filed in 2023) Statement of Economic Interest Non-Filers

The Illinois Governmental Ethics Act (5 ILCS 420/4A-101.5) mandates that elected and appointed officials of local governments file a Statement of Economic Interests with their County Clerk.

Pursuant to 5 ILCS 420A-107, the failure to file your required Statement of Economic Interest may result in action taken by the State's Attorney's Office to enforce the Act, and could result in the forfeiture of the office or position of employment for which the statement was initially required. Individuals may also be charged with a Class A misdemeanor should it be deemed appropriate.

Filer's names were provided to our office as persons who are required to file by the Unit of Government(s) that they serve. The original filing deadline was May 1, 2023, a filing grace period was granted, and our office mailed out multiple letters and statements to filers in an attempt to collect their filings. The DeKalb County State's Attorney's Office additionally sent out a letter in an attempt to collect their filings yet again in August of 2023.
