## NOTICE OF CONSOLIDATED ELECTION

NOTICE IS HEREBY GIVEN that on Tuesday, April 1, 2025, at the usual Polling Places in the various precincts in the County of DeKalb and State of Illinois, a Consolidated Election will be held for the purpose of voting for the following offices and deciding local propositions or referenda.

**TO BE ELECTED:**

**MUNICIPAL** – Mayor or President, Clerk, Treasurer, Alderperson or Trustee

**TOWNSHIP** – Supervisor, Clerk, Assessor/Multi- Township Assessor, Highway Commissioner, Trustees

**PARK DISTRICT** – Commissioners

**PUBLIC and TOWNSHIP LIBRARY** – Trustees

**REGIONAL BOARD OF SCHOOL TRUSTEES** - Trustees

**SCHOOL DISTRICT** – Board Members

**COMMUNITY COLLEGE DISTRICT** – Trustees

**FIRE PROTECTION DISTRICT** – Trustees

**LOCAL PROPOSITIONS AND/OR REFERENDA WILL BE HELD  
IN THE FOLLOWING JURISDICTIONS:**

**SYCAMORE COMMUNITY UNIT SCHOOL DISTRICT 427**

Shall the members of the Board of Education of Sycamore Community Unit School District No. 427, DeKalb and Kane Counties, Illinois, be elected at large and without restriction by area of residence within the school district?

**SOUTH GROVE TOWNSHIP**

Shall South Grove Township, Illinois, be authorized to levy a new tax for IMRF (Illinois Municipal Retirement Fund) purposes and have an additional tax of .02181 % of the equalized assessed value of the taxable property therein extended for such purposes?

**SOUTH GROVE TOWNSHIP**

Shall the limiting rate under the Property Tax Extension Limitation Law for South Grove Township, Illinois, be increased by an additional amount equal to 7 .8% above the limiting rate for the purpose of IMRF {Illinois Municipal Retirement Fund) for levy year 2025 and be equal to 0.30039% of the equalized assessed value of the taxable property therein for levy year 2025, 2026, 2027, 2028.

- (1) For the 2025 levy year and thereafter, the approximate amount of the additional tax extendable against property containing a single family residence and having a fair market value at the time of the referendum of \$100,000 is estimated to be \$7.20.
- (2) The approximate amount of the taxes extendable at the most recently extended limiting rate is \$77,008, and the approximate amount of taxes extendable if the proposition is approved is \$83,037.

**KANELAND COMMUNITY UNIT SCHOOL DISTRICT 302**

Shall the Board of Education of Kaneland Community Unit School District Number 302, Kane and DeKalb Counties, Illinois, alter, repair and equip school buildings and improve the sites thereof, including but not limited to repairing and replacing infrastructure and mechanical systems; replacing roofs and updating playgrounds at the elementary school buildings; improving learning spaces, restrooms, the main entrance and athletic facilities at the Kaneland High School Building and building and equipping a fieldhouse addition thereto; build and equip maintenance and transportation facilities; and issue its bonds to the amount of \$140,274,000 for the purpose of paying the costs thereof?

**PROPOSITION TO INCREASE THE LIMITING RATE OF THE SHABBONA FIRE PROTECTION DISTRICT**

Shall the limiting rate under the Property Tax Extension Limitation Law for the Shabbona Fire Protection District, DeKalb County, Illinois, be increased by an additional amount equal to 0.275% above the limiting rate for fire protection and ambulance purposes for levy 2023 and be equal to 0.60% of the equalized assessed value of the taxable property of the levy year 2025?

- (1) The appropriate amount of taxes extendable at the most recent extended limiting rate is \$232,770.33 and the appropriate amount of taxes extendable if the proposition is approved is \$349,868.74.
- (2) For the 2025 levy year the approximate amount of the additional tax extendable against property containing a single-family residence and having a fair market value at the time of referendum of \$100,000 is estimated to be \$194.00.
- (3) If the proposition is approved, the aggregate for 2026 will be determined by the limiting rate set forth in the proposition, rather than the otherwise applicable limiting rate calculated under the provisions of the Property Extension Limitation Law (commonly known as the Property Tax Cap Law).

**FLEWELLIN MEMORIAL LIBRARY**

Shall a public library district, to be known as the Flewellin Memorial Library District, be established in part of DeKalb County and in part of Lee County and under the Property Tax Extension Limitation Law, may an aggregate extension, not to exceed \$90,000, be made for the 2025 levy year?
