## Nonpartisan Candidate

- Runs for offices where party labels do not appear on the ballot by law.
- Common for school boards, park boards, library boards, community colleges, and some local referenda.
- Petitions and ballots list only the candidate's name no party, no "Independent," nothing.

## **We would be a seriour and a s**

- **Independent** = still part of a partisan election (ex: county board, city office, state/federal office) but chooses *not* to affiliate with a party → will be listed as *Independent* on the ballot.
- Nonpartisan = the office itself is legally nonpartisan → nobody has party labels, so you're simply "Jane Smith."
